

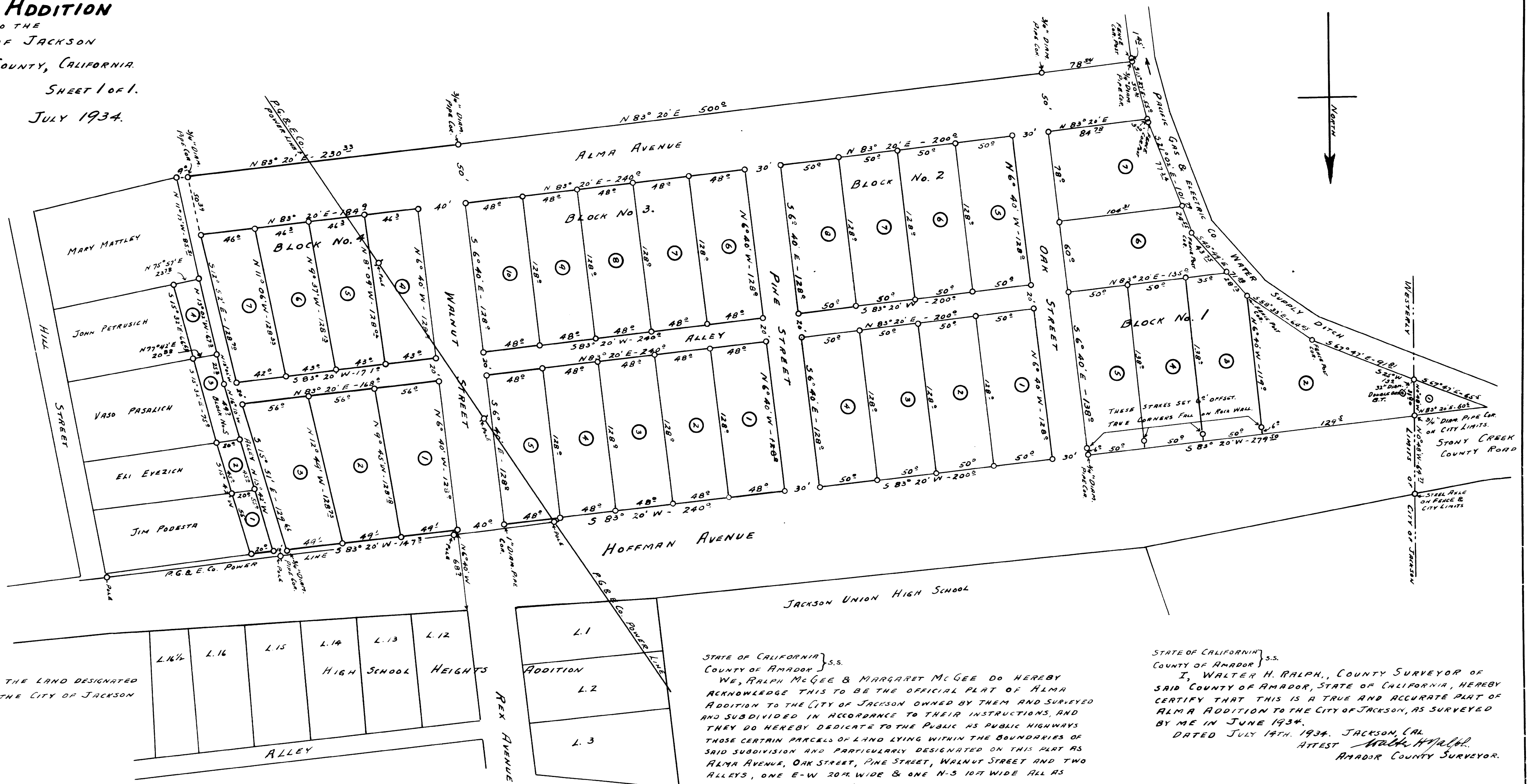
PLAT OF ALMA ADDITION
